Fire Department Insurance, Brush Dump, Garage Telephone, Cemetery expenses, Gravel, Library, Nixon Lake Road, Star Lake Room Tax, Capital Outlay, TRID & Multi-modal grants, Library Youth Assistant, and the Star Lake Cemetery. The Board members and Town Clerk took the time to thoroughly address each subject that was brought up.

Special Town Meeting of November 19, 2019

Meeting was held at the Town Hall in Sayner and called to order by Chairman Maines at 6:34 pm who noted that this meeting has been duly posted with notices placed at the Sayner Post Office, Star Lake Post Office, the Town Hall in Sayner and also on the Town website. Chairman Maines asked for a motion to appoint a chairman for the meeting. Clerk Brooker made a motion to appointed Will Maines, Jona Eliason seconded, motion carried. Chairman Maines said the purpose of the meeting was to ask electors to approve the 2019 tax levy to be collected in 2020. Chairman Maines then asked if there were any questions on the proposed town levy. Clerk Brooker fielded the only two questions. One elector asked what the total of the town tax levy was. Clerk Brooker stated \$567,461.00. The other question was about a 300% increase in revenue which she answered was the \$250,000 loan the Town will be getting. Chairman Maines asked for a motion to approve the 2019 town tax levy to be collected in 2020 of \$567,461.00. Supervisor Wiggerhauser made the motion, Danelle Schmidt seconded. Votes: AYE: 14 NAY: 0 ABSTAINED: 0; motion carried. Chairman Maines asked for a motion to adjourn the meeting. Bob Munsen made the motion, Dale Buss seconded, carried.
